Quick Summary

The U.S. Department of Labor Bureau of International Labor Affairs published three reports on international child labor and forced labor. These Department of Labor reports are their "Findings on the Worst Forms of Child Labor"; "List of Goods Produced by Child Labor or Forced Labor", and "List of Products Produced by Forced or Indentured Child Labor." Each report has a distinct mandate, focus, and set of implications, but taken collectively, they document the current situation of child labor, forced labor, and forced child labor around the world. The Findings on the Worst Forms of Child Labor report found that "This year, of the 131 countries and territories we assessed, nine countries—Argentina, Colombia, Costa Rica, Côte d'Ivoire, Ecuador,

Guatemala, Honduras, Jordan, and Uzbekistan—received the highest assessment of Significant Advancement." Additionally, they found that twenty-two countries—Armenia, Azerbaijan, Cambodia, the Central African Republic, Falkland Islands (Islas Malvinas), Gabon, Iraq, Kazakhstan, Kenya, Kyrgyz Republic, Mali, Mauritania, Moldova, Montserrat, Pakistan, Saint Helena, Ascensión, and Tristán da Cunha, Somalia, Timor-Leste, Tonga, Ukraine, Yemen, and Zimbabwe "implemented or maintained a law, policy, or practice related to access to education, the minimum age for work, labor inspection, impunity for perpetrators, criminal treatment of victims, or the recruitment and use of child soldiers that undermined advancement." In honor of World Mental Health Day, UNICEF USA highlighted the importance of the MINDS Act (H.R. 3988) (S.2105). The MINDS Act supports "the integration of mental health services in U.S. foreign assistance programming, with a particular focus on children, their families, and other vulnerable populations." Currently, the MINDS Act has 55 cosponsors in the House and new ones continue to be added. Additionally, InterAction has called on the House and Senate Leadership to take up the MINDS Act as a priority bill. If you are an InterAction member, click here to add your name by October 14th.

<u>UNICEF USA</u>, <u>World Vision</u>, <u>Catholic Relief Services</u> and <u>Save the Children</u> also have petitions to Congress, which are seeking endorsements.

The Children's Policy & Funding Initiative held its annual Grantee Workshop to review grantee joint actions, achievements, and future plans to make children and youth a higher priority in US foreign assistance. Accomplishments included developing joint advocacy proposals that call for child impact statements, better budget tracking, and a Cross-Agency Priority (CAP) goal by OMB; the inclusion – for first time – of budget tracking requirements for funds supporting children and youth as well as mental health programs in the FY2023 House and Senate State and Foreign Ops Appropriations Bills Report; and the creation of the Initiative's Youth Alliance Working Group to increase youth engagement in developing priorities and in advocacy with policymakers. Spotlight

First Focus on Children held its annual Children's Budget Summit 2022 and launched its 2022 Children's Budget Book. **Senator Ron Wyden**, **Chairman of the Senate Finance Committee**, kicked off the discussion with policymakers, experts, and advocates to analyze the report's findings and its implications for future policy. **The White House**

Office of Management and Budget <u>Director Shalanda Young</u> joined the Summit in a recorded conversation with <u>Bruce Lesley</u>, President of First Focus.

areas of environmental health on children. The Children's Budget 2022 found that the share of U.S. domestic and international spending on children "rose 21% over the last five years, making up 11.98% of all federal spending in FY 2022 (11.88% for domestic, 0.10% for international). This share stands in stark contrast to pre-pandemic investments when the total share of federal spending on children was only 7.55% of the federal budget." However, with inflation-adjusted, "dollars for children dropped nearly 17% between FY 2021 and FY 2022."

Global crises, including the ongoing COVID-19 pandemic, are upending the lives of children and youth around the world. In under-resourced parts of the world, this "confluence of challenges is undermining decades of progress to improve children's health and well-being. Children and young people internationally receive a minimal share of foreign assistance funding. Only about \$.085 of every \$1 of foreign assistance investments benefitted children."
